

## WINTER WEATHER ADVISORY BULLETIN

Cumberland Heights' River Road facility is located in an area where snow and ice are not uncommon during the winter months and may pose hazards to drivers on River Road as well as persons on the Cumberland Heights' campus. Also, this residential site is located 7.5 miles on a rural highway that is known for being shaded and curvy. For this reason, a winter weather advisory bulletin is being issued to all patients, family members, aftercare attendees, staff and other visitors.

In the event of predicted or actual snow and/or ice fall on River Road and its surrounding area, please note the following:

- This bulletin will be reissued when local weather authorities are predicting moisture and/or precipitation and/or temperatures that are expected to fall below 32 °F.
- The Critical Staffing policy will be activated to determine the minimum number of staff required on site to adequately provide for the care of the patients.
- Local television and radio stations are contacted so they can report travel advisories for this area and/or cancellations of services (i.e., River Road IOP, aftercare, Crossover).
- The Winter Weather Advisory Phone Line for River Road will feature voice message updates with the date/time of travel advisories for this area and/or cancellations of services.
- Staff will be receiving regular *E-mail updates* communicating the most current weather conditions and/or forecasting. This information will be passed along to others, including incoming assessments and/or admissions.
- *Caution signs* will be posted along the driveway and near steps/entrances to buildings.
- Containers of *Ice Melt* will be available to staff and others to use on steps and walkways as needed.

## CAUTION: WHEN SNOW & ICE PRESENT

Parking lots & walkways may be covered with ice and/or snow. Please use caution when moving about the campus. Your safety is important to us!

- Movement of persons on campus should be kept to a minimum to prevent slips, falls or other injuries
- Caution signs will be posted throughout the campus to alert you of snow/ice.
- Primary areas, including parking lots and walkways, will be cleared as much as possible.
- Patients will be advised to remain indoors after 9 pm or before 7 am.
